e) Wednesday Chairman: Chuck Newman

- LAST 2013 Play Date: 27 November 2013 with a 9A shotgun start; no Thursday play since it is Thanksgiving Day.
- FIRST 2014 Play Date: 5 February 2014; Entries will be taken on 29 January 2014 from 8-10A

- f) Golf Advisory Board: Gerry Quinlan
 - The most recent meeting of the MGAB was held on Thursday, October 17, 2013 at the Arroyo Del Oso Golf Course clubhouse.
 - YTD FY13 (3 months) golf rounds are down 9%, green fee revenue is down 4.5%. Note: September was very wet.
 - The City Golf Budget Report can be found on page 87 of the document at http://documents.cabq.gov/budget/fy-13-approved-budget.pdf
 - An ad hoc advisory budget committee (Gerry Quinlan, Jim Crane, Rusty Arrighetti, John Perner consulting) has been formed, to meet every two weeks or so, outside the regular MGAB meeting cycle, to consider the Golf Management budget process. The first meeting was held on November 7. Only Quinlan and Perner attended, with Tim Martinez, Albuquerque Golf Management, so no business was conducted.
 - Ladera continues to improve. Both nines of the 18-hole course are open.
 - City Golf Management is negotiating an agreement to have Metropolitan Detention Center inmates perform maintenance chores at the city courses.
 - The city is considering converting #13 at Los Altos to a par 4 by moving the tee box back to the boundary of the short course, about 40 yards.
 - The back tee box on #14 at Los Altos cannot be used on a regular basis until a net of appropriate height is installed on the south boundary of the hole. The required height of such a net has yet to be determined, but will probably be at least 100'. The exact height will be based on the recommendation of a consultant, who is yet to be appointed.
 - The next meeting will be held on Thursday, November 20 at 3:00 PM at the Los Altos Golf Course Banquet Room.

g) Tournament Report: Gary Schuster

- The November Turkey Shoot tournament had a good turnout. 6 more people played this year than last year.
- Gary will be sending out emails to those who still have yet to pick up their LAGA Bucks certificate cash. If they are still not picked up by 24 December they will be converted to Los Altos Pro Shop certificates. He wants to clear up the books before the EOY.
- h) Handicap: Gerry Quinlan Member who had their handicap adjusted for most of the 2013 season, will back to normal GHIN handicap in 2014.

V. Old Business

- Christmas Party will be 17 December 2013 starting @ 6P
 - ACTION: Wally Iverson & Tom Michel will be in charge of getting most, if not all, the door prizes and raffle items for the party.
 - Food will be \$30/plate for Prime Rib & Fish choices; that is \$4 more than last year for the same menu. LAGA had 7 guests that the association paid for in 2012.
 - Because of the higher costs of the assorted prizes & food, it was agreed that we needed to increase the amount allotted for the Christmas party from \$550 to \$1000. We also agreed to subsidize the food to the tune of \$5/person (\$25/person to pay towards the \$30/plate cost).


